# In Memoriam Ernie Shelton

Ernie Shelton, a friend, motivator and father figure to thousands of students, died Sunday after losing his fight with lung cancer. Shelton was 55.

Mr. Shelton, a 28-year Fresno resident, was known in nearly every pocket of the community where people were in need.

He counseled students, coached basketball, organized a choir and fought for improvements in southwest Fresno.

Mr. Shelton worked as outreach coordinator at California State University, Fresno. He joined the college in 1971 and held several positions including coordinator of Veterans/Disabled Student Services.

His wife, Inez, said it wasn't uncommon for her husband to leave for work at dawn and not be home until late at night.

"He really liked helping people, especially young people," she said. "That really kept him going."

Mr. Shelton's contributions did not go unnoticed.

In February, he was inducted into the State Center Community College District's "Wall of Honor."

At Fresno City, he served as an unpaid assistant basketball coach for 14 years. He also funded the Fresno State/Fresno City Black Gospel Choir.

Mr. Shelton was a member of the Fresno County Board of Education, representing District 1, since 1994.

Mr. Shelton was also a member of the United Black Men of Fresno, Cecil Hinton Community Center, Focus for Life and the ROP Advisory Board.

He is survived by his wife and two sons, Ernie Shelton III, 22, and Cedric Shelton, 8, and eight stepchildren.
