Dear Mr. Wilson: I am today, at the request of Chairman Hertzberg, reducing the size of the Assembly Public Safety Committee from its current membership of 13 to eight.

The bill load of this committee is more than substantial, constituting more than a third of the total committee workload of the House. The subject matter deals with the protection of public safety. Proponents and opponents deserve a committee which is neither unwieldy in size, nor one with members who have other committee conflicts.

There are 41 bills on calendar for tomorrow. If each received only 15 minutes, the hearing would require ten hours. I expect it to last substantially longer.

The reduced committee will have the following membership: Assemblymembers Robert Hertzberg, Chair, Jan Goldsmith, Vice Chair, Larry Bowler, George House, Kevin Murray, Grace Napolitano, Don Perata and Carl Washington.

The partisan balance of the earlier committee is retained: I have removed three Democrats and two Republicans. Besides the Vice Chair, I have retained the two minority members who have previous experience on the committee.

To accommodate similar concerns, I have also reduced the size of two other committees. The Natural Resources Committee is reduced in size from 14 members to 12 members. Assemblymembers Steven T. Kuykendall and Kerry Mazzoni are removed.

The Water, Parks and Wildlife Committee is reduced in size from 17 members to 15 members. Assemblymembers Grace Napolitano and Nao Takasugi are removed. Assemblymember Takasugi is appointed to the Consumer Protection, Governmental Efficiency and Economic Development Committee to fill an existing vacancy.
