Officer Martinez died last Thursday from severe head injuries he sustained on May 8th when he committed the most noble act of bravery to protect his partner from an oncoming vehicle. He minimized the injury to his partner while sustaining fatal injuries himself.

Governor Wilson will award Officer Martinez the Medal of Valor. The medal is the highest award the Governor can bestow upon a state employee. The Governor has awarded only 44 medals since taking office in 1991.

Officer Saul Martinez was very active in his community and church. A wake was held for him over the weekend where over 5,000 people were in attendance to pay their respects to his family.

Officer Martinez is survived by his wife of 15 years, Remedios, and their three children: Elizabeth, Saul Jr. and Carolina.
