Veto Message—Assembly Bill No. 1459

Governor's Office, Sacramento

July 3, 1997

To the Members of the California Assembly:

I am returning Assembly Bill No. 1459 without my signature.

This bill would make the First Year Law Students Examination (Baby Bar) advisory for students who enter an unaccredited law school after earning a bachelors degree.

The Baby Bar was established in 1935 and has been found to promote a legitimate state interest by the California Supreme Court in *Bib'le* v. *Committee of Bar Examiners* (1980) 26 Cal 3rd 548.

Because these schools are nonaccredited, this examination is currently the only standard available to students attending these schools by which to determine the quality of education that they are receiving. Additionally, the results of the examination also assist the student in determining whether he or she has the potential to become an attorney.

Last year, after vetoing bills conceptually indistinguishable from this one in 1994 and 1995, I signed SB 1950 (Mello). The Mello bill sought to grant relief to the students of unaccredited law schools who suffer uncertainty after failing the Baby Bar. The bill allows such students two additional opportunities to pass the exam without disrupting their studies or losing credits.

The Mello bill was perceived to be a reasonable compromise recognizing the concerns of both the State Bar and the unaccredited schools. This bill, brought forth by the same proponents within weeks of the earlier bill's effective date, abrogates most of the effect of the Mello bill and reverts to the position that the Baby Bar become largely advisory. The same position was rejected in both 1994 and 1995. The distinction that this bill applies only to applicants who have a bachelors degree is hardly compelling. Most individuals seeking a graduate degree first acquire a bachelors degree.

MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 1501

Governor's Office, Sacramento July 7, 1997

To the Members of the California Assembly:

I am returning Assembly Bill No. 1501 without my signature.

It is one of a package of bills that purport to reform welfare. Taken together, these bills would make a number of changes to the Aid to Families with Dependent Children (AFDC) Program. The more significant changes in this bill include creating a new child care system and establishing a loan guaranty and direct loan funds for the construction, expansion or improvement of child care facilities. The bill would also create the Job Creation Investment Fund and permit recipients to participate in a self initiated education program even if the recipient is employable.

After a careful review of these bills, it is apparent that they represent a stunning rejection of both the spirit and the letter of The Personal Responsibility Act signed by President Clinton last summer. Instead, the policies embodied in these bills not only perpetuate a gravely flawed system that discourages work, encourages dependency and inhibits a county's ability to design a system specific to the needs of their community and neediest citizens, they make it worse. Much worse.

Specifically—to cite a few of the flaws created—these bills: exempt hundreds of thousands of recipients from work requirements;

make a mockery of time limits and work requirements even for those not exempted;

not only fail to produce the savings clearly anticipated by the President and Congress (and already achieved by other states that have enacted true reform), but impose huge new unfunded state costs because of the new and expanded guaranteed benefit programs, which would require either new taxes or deep cuts in existing state health, education, public safety or other state benefit programs;

expand eligibility and therefore caseload thus raising the threshold for meeting federal work requirements and assuring future penalty if California has not increased the number of recipients working;

make a mockery of workforce by reducing the number of hours to be worked by the recipient to a fraction of the work-week expected of working taxpayers, and far less even than the twenty hours per week required by federal law, triggering federal penalty; deny counties any financial incentive to make the energetic effort required at the local level to succeed in moving recipients from welfare to work by failing to permit them to share in program savings;

increase the cost of child care by adding new requirements which limit parental choice; and potentially serious under-fund child care;

create a bureaucratic procedural safe haven for recipients who refuse valid job offers;

ignore the clear lesson learned by and the success of counties which have implemented the "work first" approach to job placement, instead encouraging the deferral of work experience for up to 2 years;

seriously diminish our ability to eradicate welfare fraud; fail to require, as a condition of receiving the grant, that the recipient assure that the paternity of recipient children is established, assure that their children attend school, and assure that their children obtain required immunization without delay; and

fail (I assume inadvertently) to exclude as eligible recipients 17,000 fugitive felons and heaven only knows how many drug felons.

To repeat, these are a few of the more grievous defects of this package of bills.

Reform must include a system that gives counties maximum flexibility and fiscal incentives to help people move from welfare to work within statewide program standards. The current system is driven by volumes of state and federal rules which strive for bureaucratic uniformity and discourage county initiative. The existing system must be replaced by one that responds to welfare recipients as individuals, eliminates barriers to work, and uses the tools necessary and available at the local level to move recipients into the workforce.

Instead, the system designed in this proposal expands and enshrines bureaucratic uniformity. Indeed the proposal is so excessively prescriptive that new waiver authority is included to permit a county to modify work incentives for specified residents.

This package of bills in short has been designed and crafted to defeat the very purposes of the Federal Personal Responsibility Act to which it purports to respond, and to achieve an entirely contradictory result.

I can only assume that it was crafted by the most over-zealous of welfare rights advocates; and that many members of the majority who voted for these bills had no real understanding of their provisions or pernicious impacts. These bills are unfair both to recipients and their children whom it offers not temporary aid, but prolonged dependency—and to working taxpayers upon whom it would pile significant new burdens.

With all its manifest, serious defects, the present failed welfare system is significantly less threatening than the expanded one these bills would put in place. The Federal Personal Responsibility Act demands a response. This performance is worse than disappointing, especially when compared to the genuine reforms enacted by other states.

The clock is running. I respectfully ask that the Legislature send me true welfare reform without further delay.
