School District Reorganization—#16331

Dear Mr. Kuykendall:

QUESTION

Does subdivision (b) of Section 35700 of the Education Code and subdivision (b) of Section 35721 of the Education Code apply to school district reorganizations where a community that is part of one school district with over 200,000 pupils in average daily attendance wants to secede from that school district and become part of another existing school district?

OPINION

Subdivision (b) of Section 35700 of the Education Code and subdivision (b) of Section 35721 of the Education Code do not apply to school district reorganizations where a community that is part of one school district with over 200,000 pupils in average daily attendance wants to secede from that school district and become part of another existing school district.

ANALYSIS

By way of background, a general discussion of the procedures to reorganize a school district may be helpful. In that regard, Chapter 3 (commencing with Section 35500) and Chapter 4 (commencing with Section 35700) of Part 21 of the Education Code ¹ (hereafter Chapter 3 and Chapter 4, respectively) contain the statutory provisions governing the reorganization of school districts. An action to "reorganize" school districts may be an action to form, dissolve, or lapse a school district, the annexation of all or part of the territory of one district to another, the transfer of all or part of one district to another, the unification of a school district, any other alteration of the boundaries of a school district, or any combination of all of those actions (Sec. 35511).

Thus, an action to reorganize school districts pursuant to Section 35511 includes the situation where a community that is part of one school district secedes from that school district and becomes part of another existing school district. This kind of reorganization is generally referred to in Chapter 3 and Chapter 4 as a territory transfer (see Secs. 35706, 35709, and 35710).

An action to reorganize a school district may be commenced, alternatively, by different persons or entities and pursuant to different statutory provisions. More specifically, an action to reorganize a school district may be commenced either by petition of voters, property owners, or members of governing boards of school districts (see Art. 1 (commencing with Sec. 35700), Ch. 4, Pt. 21), or by voters or the county committee on school district organization (hereafter county committee) (see Art. 2 (commencing with Sec. 35720), Ch. 4, Pt. 21).

As to an action to reorganize a school district that is initiated by petition of voters, property owners, or members of governing boards of school districts, Section 35700 provides as follows:

"35700. An action to reorganize one or more districts is initiated upon the filing, with the county superintendent of schools, of a petition to reorganize one or more school districts signed by any of the following:

"(a) At least 25 percent of the registered voters residing in the territory proposed to be reorganized if the territory is inhabited. Where the petition is to reorganize territory in two or more school districts, the petition shall be signed by at least 25 percent of the registered voters in that territory in each of those districts.

"(b) A number of registered voters residing in the territory proposed to be reorganized, equal to at least 8 percent of the votes cast for all candidates for Governor at the last gubernatorial election in the territory proposed to be reorganized, where the affected territory consists of a single school district with over 200,000 pupils in average daily attendance and the petition is to reorganize the district into two or more districts.

"(c) The owner of the property, provided that territory is uninhabited and the owner thereof has filed either a tentative subdivision map with the appropriate county or city agency or an application for any project, as defined in

Section 21065 of the Public Resources Code, with one or more local agencies.

"(d) A majority of the members of the governing boards of each of the districts that would be affected by the proposed reorganization." (Emphasis added.)

Thus, subdivision (b) of Section 35700 provides that an action to reorganize is initiated upon the filing, with the county superintendent of schools, of a petition to reorganize signed by the number of registered voters residing in the territory proposed to be reorganized, equal to at least 8 percent of the votes cast for all candidates for Governor at the last gubernatorial election in the territory proposed to be reorganized, where the affected territory consists of a single school district with over 200,000 pupils in average daily attendance and the petition is to reorganize the school district into two or more districts.

The issue we address in this opinion as to subdivision (b) of Section 35700 is whether this provision applies to a territory transfer where the territory to be transferred is in a school district with over 200,000 pupils in average daily attendance. We begin by noting that only the Los Angeles Unified School District has over 200,000 pupils in average daily attendance. In 1995, the Los Angeles Unified School District had an enrollment in excess of 750,000 pupils (*California Public School Directory* (1995), p. 210).

To ascertain the meaning of a statute, we look to the language in which the statute is framed (*Leroy T. v. Workmen's Comp. Appeals Bd.*, 12 Cal. 3d 434, 438). Where a statute is susceptible to two constructions, the one that leads to the more reasonable result will be followed (*Metropolitan Water Dist. v. Adams, 32* Cal. 2d 620, 630–631).

Section 35700 generally applies to territory transfers and to other reorganizations involving two or more school districts. For example, the first paragraph of Section 35700 provides for petitions to reorganize one or more school districts. Moreover, subdivision (a) of Section 35700 provides that where a petition is to reorganize territory in two or more school districts, the petition shall be signed by at least 25 percent of the registered voters in the territory in each of those school districts. Finally, subdivision (d) of Section 35700 provides that a petition to reorganize two or more school districts may be initiated and signed by a majority of the members of the governing boards of each of the school districts that would be affected by the school district reorganization.

In contrast, subdivision (b) of Section 35700 does not specify a method to include the voters residing in the school district where the territory would be transferred within the petition process. This difference in subdivision (b) indicates that the Legislature did not intend to include within that subdivision, as it did in the other subdivisions of Section 35700, territory transfers or reorganizations involving two or more school districts. The words in a statute are to be given their ordinary meaning unless a different meaning is clearly intended (*Hazelwood* v. *Hazelwood*, 57 Cal. App. 3d 693, 698) and subdivision (b) of Section 35700 provides that an action to reorganize may be initiated pursuant to this subdivision when the affected

territory "consists of a single school district" and the petition is to reorganize the school district "into two or more districts."

Moreover, Section 35706 provides that, within 120 days of the commencement of the first public hearing on the petition, the county committee is required to recommend approval or disapproval "of a petition for unification of school districts or for the division of the territory of an existing school district into two or more separate school districts, as the petition may be augmented, or shall approve or disapprove a petition for the transfer of territory, as the petition may be augmented." This section, and Sections 35709 and 35710, which also set forth specific procedures for a reorganization involving a transfer of territory, indicate that the Legislature views a reorganization of an existing school district into two or more school districts differently than a reorganization involving a transfer of territory. In view of the rule of statutory construction which provides that a phrase or expression may be interpreted in accordance with its use in other related statutes (Frediani v. Ota, 215 Cal. App. 2d 127, 133), in our view the Legislature did not intend subdivision (b) of Section 35700 to apply to territory transfers.

Thus we conclude that subdivision (b) of Section 35700 does not apply to school district reorganizations where a community that is part of one school district with over 200,000 pupils in average daily attendance wants to secede from that school district and become part of another existing school district.

We now turn to Section 35721 which provides as follows:

"35721. (a) On receipt of a petition signed by at least 10 percent of the qualified electors residing in any district for a consideration of unification or other reorganization of any area, the county committee shall hold a public hearing on the petition at a regular or special meeting.

"(b) On receipt of a petition signed by at least 5 percent of the qualified electors residing in a school district with over 200,000 pupils in average daily attendance in which the petition is to reorganize the district into two or more districts, the county committee shall hold a public hearing on the petition at a regular or special meeting.

"(c) Following the hearing conducted pursuant to subdivision (a) or (b), the county committee shall grant or deny the petition. If the county committee grants the petition, it shall adopt a tentative recommendation following which action it shall hold one or more public hearings in the area proposed for reorganization. The provisions of Sections 35705 and 35705.5 shall apply to any such public hearing." (Emphasis added.)

Thus, subdivision (b) of Section 35721 provides that a petition may be signed by at least 5 percent of the qualified electors residing in any school district with over 200,000 pupils in average daily attendance in which the petition is to reorganize the school district into two or more school districts.

This provision, like subdivision (b) of Section 35700, pertains to a petition to reorganize a school district into two or more school districts. A statute should be interpreted with reference to the

system of law of which it is a part (*People v. Comingore*, 20 Cal. 3d 142, 147). Thus, the words in subdivision (b) of Section 35721 should be interpreted in the same manner as the identical words in subdivision (b) of Section 35700.

Thus, subdivision (b) of Section 35721 does not apply to school district reorganizations involving a transfer of territory.

In conclusion, subdivision (b) of Section 35700 of the Education Code and subdivision (b) of Section 35721 of the Education Code do not apply to school district reorganizations where a community that is part of one school district with over 200,000 pupils in average daily attendance wants to secede from that school district and become part of another existing school district.
