MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 676

Governor's Office, Sacramento August 8, 1997

To the Members of the California Assembly:

I am returning Assembly Bill No. 676 without my signature.

This bill would require any school district applying for funding pursuant to the Leroy F. Greene State School Building Lease-Purchase Law of 1976 (Greene Act) to include in its plans for any new or modernized permanent or portable classroom a hard-wired or wireless connection to a public switched network.

This bill is nearly identical to AB 2371, which I vetoed last year. While the author has attempted to address one objectional provision contained in AB 2371, that of the state overreaching its duty by specifying the technology for each classroom, this bill would still mandate the inclusion of a telephone in each classroom. As I stated in last year's veto message, the option to include a telephone in a classroom, whether hard-wired or wireless, is already permissible under current law. Nothing in the law has changed with regard to a school district governing board's role in this aspect of school facilities planning and construction. Technology is changing so rapidly that no one method should be mandated by the state.

Finally, this bill would limit a governing board's discretion to fund other projects which it may consider a higher priority. Local governing boards have a responsibility to respond to the needs of the community they serve. The state has a responsibility to allow these local governing boards the flexibility to perform their duties to the best of their abilities.
