MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 1153

Governor's Office, Sacramento August 26, 1997

To the Members of the California Assembly:

I am returning Assembly Bill No. 1153 without my signature.

Among other things, this bill would effectively exempt the Unemployment Insurance (UI) and State Disability Insurance (DSI) programs within the Employment Development Department (EDD) from any changes in eligibility criteria and standards based on provisions of the federal welfare reform bill. The bill would also, subject to appropriation in the annual Budget Act, require the Community Services and Development (CSD) Department to contract with, and allocate funds to, citizenship assistance providers in order to assist legal noncitizen immigrants with the naturalization process.

In order to discourage state benefits that will encourage illegal immigration, federal welfare reform legislation includes a requirement that no benefits under public assistance programs be paid to illegal residents without subsequent enactment of a state statute specifically authorizing the benefit. This bill would permit

the payment of UI and SDI benefits to illegal residents. It clearly violates the spirit of federal policy that wisely seeks to discourage illegal immigration by removing incentives for it. It is inconsistent and hypocritical for government to penalize the hiring of illegal immigrants and in the next breath authorize employment-based benefits that can only stimulate illegal entry and further violation of federal law.

Federal funds are allocated each year to the California Department of Education (CDE) for adult education, which includes some funding for citizenship education. In recognition of the importance of citizenship services, the Budget Act of 1997 provides a reappropriation of \$3 million federal funds to CSD and an appropriation of \$12.6 million in federal adult funds to the California Department of Education. These resources should meet the needs for naturalization assistance and citizenship education without the need for creating a general fund program.

Currently, the CDE receives federal funds annually to administer the English as a Second Language Citizenship Program. Although CSD received a one-time appropriation in unspent federal funds in the fiscal year 1994–95 State Budget for citizenship education assistance, continuing to fund citizenship education programs through CSD would expand the current role of the department and would shift program responsibilities from CDE.
