Veto Message—Assembly Bill No. 1602

Governor's Office, Sacramento September 2, 1997

To the Members of the California Assembly:

I am returning Assembly Bill No. 1602 without my signature.

This bill would provide that when the assets of a medical center owned by the state are transferred or leased to a private corporation, those assets shall be subject to continued oversight by the Legislative Analyst, the Budget Committees of the Senate and Assembly, and the Joint Legislative Audit Committee.

This bill arises from the proposed merger of the University of California San Francisco Medical Center and Stanford Health Services to form a new private non-profit corporation: University of California, San Francisco Stanford Health Care (''USHC''). The intent of the bill is to ensure public accountability of state owned assets that are transferred or leased to a private entity such as USHC. This bill, however, goes beyond what is prudent in protecting the public interest.

The existing health care environment is extremely competitive. Legislative oversight of a private corporation will harm the corporation's ability to compete because sensitive management, financial and contract information will be made public during the legislative process. Other options must be considered that balance the need for public accountability and the requirement that any new entity formed with public assets be able to compete in the healthcare marketplace.
