Mr. Speaker and Members of the Assembly: I am offering amendments to AB 1614 that restate more clearly an author's amendment I offered that was approved without opposition by the Revenue and Taxation Committee on July 14. In that Committee, I offered an amendment to allow continuation of local utility taxes as they apply to basic charges for telephone, cable of cellular telephone service, even though the customer might use their cellular or landline telephone or cable television to access the Internet some or all of the time. I also offered to work with interested local government representatives to resolve concerns about the application of cable franchise fees to charges for interactive computer services. The cable franchise fee issue was subsequently addressed by author's amendments added in the Televising the Assembly and Information Technology Committee on August 29 ((Section 65004(b)(7)).

At the same time, however, I made it clear that I did not want the utility users tax to apply to additional charges made specifically for Internet access. For example, if the basic charge by a local telephone company for monthly telephone service is \$10.00, my intent was for

utility users taxes to continue to apply to that charge, even though the customer may use his or her telephone line to access the Internet. On the other hand, if an interactive computer service, such as Netcom or America Online, or a local telephone company, cable television company or cellular telephone company makes an additional charge specifically for (such as \$19.95 a month for unlimited Internet access), those charges are not to be subjected to the utility users tax.

The language drafted following the Revenue and Taxation Committee hearing to memorialize this amendment has met with varying interpretations, and there is great disagreement over whether the language establishes the boundary line for taxation where we agreed it was established. The amendment I am making to AB 1614 simply sharpens the language of my original amendment consistent with the Committee's action on July 14.
