Dear Mr. Wilson: AB 1061 (Machado) requires that an air district, when adopting or amending a rule or regulation, review other requirements that apply to the same equipment or source type, as specified.

This letter is to clarify the author's intent regarding two aspects of the bill.

First, in nearly all cases the term "source" will mean a specific operating unit or piece of equipment as opposed to an entire facility. The only time "source" will mean the entire facility is if the district rule in question is a rule for an entire facility as opposed to a rule that is for a specified type(s) of operating unit or equipment.

Second, the legislation is not intended to apply to adoption or amendment of district new source review rules which apply to all new and modified sources.
