Executive Department, State of California

Proclamation

WHEREAS, an extraordinary occasion has arisen and now exists requiring that the Legislature of the State of California be convened in extraordinary session; NOW, THEREFORE,

I, RONALD REAGAN, Governor of the State of California, by virtue of the power and authority in me vested by Section 3 of Article IV of the Constitution of the State of California, do hereby convene the Legislature of the State of California to meet in extraordinary session at Sacramento, California, on the fifth day of September 1967, at 2:00 P. M. of said day for the following purposes and to legislate upon the following subjects:

To consider and act upon legislation relative to statewide support of school districts in territory in which an unsuccessful unification election was held, and to school district override taxes to finance corrective measures relating to fire and panic safety.

(1) That notwithstanding the provision of Assembly Rule 14 relating to the selection of members of the Standing Committee on Rules, the members of the Standing Committee on Rules for the 1967 First Extraordinary Session shall be the same as those on the Assembly Committee on Rules of the 1967 Regular Session.

(2) That the Temporary Standing Rules of the 1967 Regular Session as adopted on January 3, 1967, and amended on January 26, 1967 and April 12, 1967, be and the same are hereby adopted as the Temporary Standing Rules for the 1967 First Extraordinary Session.

(3) That the Chief Clerk or the Sergeant at Arms be and they are hereby authorized to receipt to the Controller for all warrants for the payment of Members, Officers and Attachés of the Assembly.

(4) That the Chief Clerk is authorized to receipt from the Members of the Assembly, a mailing list of Histories and Legislative Digests, to be directed to libraries, chambers of commerce, and other public centers, and to individuals for general inspection. This list is to be limited to ten (10) names each, and shall be forwarded to the Legislative Bill Room for regular mailing. No member shall include on the list any state department or employee thereof except state colleges and universities. The Chief Clerk is further authorized to place accredited newspaper representatives on the regular mailing list as well as the Attorney General, the office of the Legislative Counsel, and the Governor's Office. No additional mailing list shall be allowed or authorized unless the sum of fifteen dollars (\$15) each is paid therefor to the State Printer, which sum shall be credited to legislative printing and accounted for to the Legislature.

School District Tax Rates—No. 26420

Dear Mr. Greene:

QUESTION

With reference to Senate Bill No. 1 of the 1967 First Extraordinary Session, you ask whether county boards of supervisors would be authorized to adjust all school district tax rates to the degree necessary to reflect changes in the revenues accruing to school districts because of the changes effected by the bill in the areawide aid computational tax rates and in the areawide taxes to be levied and collected for school district support.

OPINION AND ANALYSIS

Senate Bill No. 1 of the 1967 First Extraordinary Session of the Legislature provides, among other things, for increases in the so-called "areawide aid" computational tax rates to be used in computing State School Fund foundation program support for elementary school districts and high school districts situated within territory included within unification proposals defeated by the local electors. Section 4 of the bill directs that the revised computational tax rates be utilized in allowing and apportioning these support moneys to the districts in the 1967-1968 fiscal year. It is further specified that areawide taxes for the support of such school districts be levied and collected locally on the basis of the higher areawide aid amounts computed for purposes of the State School Fund subventions. Each county superintendent of schools is required to determine and certify to the county board of supervisors and the county auditor, on or before September 15, 1967, the new areawide aid amounts on the basis of which areawide taxes are to be levied and collected locally for distribution to the districts.

Since school district budgets will have been finally adopted prior to the enactment of Senate Bill No. 1, it is likely that the school district tax needs as therein expressed will not, in some instances, appropriately reflect the changes in revenues which will result to the districts under the revision in the areawide school support scheme effected by the bill. However, Section 4 of the bill empowers and directs county boards of supervisors, on or before September 22, 1967, to "determine the extent of any adjustments to be made pursuant to this section in the rates of areawide school support taxes and school district tax rates, and . . . fix such rates for purposes of the levy and collection of taxes for the 1967-1968 fiscal year." In addition, the facts recited in the urgency section as the basis for making the bill effective immediately upon enactment specify an essential aim of the Legislature as being to enable state and local fiscal authorities to effectuate the alignment of the areawide school tax support mechanism to the increased levels of state school support afforded by Chapter 1209 of the Statutes of 1967, with respect to both the apportionment and disbursement of state school support moneys "and the levy and collection of local taxes for school support for the 1967-1968 fiscal year . . ."

On this basis it is our opinion that the county boards of supervisors clearly would have the power, under Senate Bill No. 1, to make all necessary and appropriate revisions in school district tax rates dictated by operation of the provisions of the bill, irrespective of the district tax needs expressed in the finally adopted school district budgets
