of their respective years of origin and prior to the application of the offset which might otherwise be allowable for amounts paid during that income year.

- (c) Notwithstanding anything to the contrary contained in this section, the tax on financial corporations after the allowance of all offsets provided for herein shall not be less than 7.6 percent of its net income for the preceding income year nor less than the following minimum tax:
- (1) In the case of financial corporations, other than credit unions whose gross income is twenty thousand dollars (\$20,000) or less, one hundred dollars (\$100).

(2) In the case of credit unions whose gross income is twenty thousand dollars (\$20,000) or less, twenty-five dollars (\$25).

- (d) For purposes of this section, with respect to calendar or fiscal years ending after June 30, 1973, the tax on financial corporations after the allowance of all offsets shall not be less than 9 percent of its net income nor less than the minimum tax as provided by subdivision (c). The minimum tax rate specified in the preceding sentence shall be 10.25 percent for calendar or fiscal years ending after December 31, 1977
- (e) For income years beginning after December 31, 1971, the one hundred dollars (\$100) specified in paragraph (1) of subdivision (c) shall be two hundred dollars (\$200) instead of one hundred dollars (\$100)

SEC. 24.3. Section 23186 of the Revenue and Taxation Code is amended to read.

extent which such personal property taxes exceed such net loss allocable to California."

(A) The period of the transfer agreement, or

(B) A period of more than 10 income years, whether ending before or after the end of the period of the transfer agreement, in the income year in which the payment is made; and

(3) In the case of any other payment, in the income year or years specified in regulations prescribed by the Franchise Tax Board, consistently with the preceding provisions of this paragraph.

(c) This section shall not apply to the transfer of a franchise to engage in professional football, basketball, baseball, or other professional sport."

'(3) For the 1978-79 fiscal year, such exemption shall be in the amount of five thousand dollars (\$5,000) of the assessed value of the dwelling.

(4) (A) For the 1979–1980 fiscal year and fiscal years thereafter, such exemption shall be in the amount equal to the prior fiscal year's exemption, as adjusted by the statewide average percentage change in assessed valuation determined pursuant to this paragraph

(B) In January of 1979 and in January of each year thereafter, the State Board of Equalization shall determine the statewide average percentage change in assessed valuation from the prior fiscal year to the current fiscal year. The board shall add such percentage to 100 percent and shall multiply the total by the current fiscal year's exemption. The amount so determined shall be the amount of the homeowners' property tax exemption for the ensuing fiscal year, and such amount shall be certified by the board to each county assessor."

#### Amendment 4

On page 4, strike out lines 18 to 26, inclusive, and insert

"SEC. 2. Section 17053.5 of the Revenue and Taxation Code is

amended to read:

17053.5. (a) For taxable years beginning after December 31, 1975, in the case of qualified renters, there shall be allowed credits against the tax computed under this part, minus all other credits provided for in this part except the credit provided in Section 18551.1 (relating to withholding credit) and the credit provided in Section 17061 (relating to excess tax credit). The eredit shall be in the amount of thirty/seven dellars (\$37).

(1) For taxable years beginning after December 31, 1975, and ending before January 1, 1978, the credit shall be in the amount of

thirty-seven dollars (\$37).

(2) For the taxable year beginning after December 31, 1977, the

credit shall be in the amount of one hundred dollars (\$100).

(3) (A) For the taxable year beginning after December 31, 1978, and taxable years thereafter, the credit shall be in the amount equal to the prior year's credit, as adjusted by the statewide percentage change in assessed valuation determined pursuant to paragraph (4)

of subdivision (a) of Section 218.

(B) In January of 1979 and in January of each year thereafter, the State Board of Equalization shall certify to the Franchise Tax Board the statewide average percentage change in assessed valuation from the prior fiscal year to the current fiscal year. The Franchise Tax Board shall add such percentage to 100 percent and shall multiply the total by the prior year's credit. The amount so determined shall be the amount of the credit for the taxable year ending before January 1 of the ensuing year.

(4) Except as provided in subdivision (b) of this section a husband and wife shall receive but one credit under this section. If the husband and wife file separate returns, the credit may be taken by

either or equally divided between them, except as follows:

(A) If one spouse was a resident for the entire taxable year and the other spouse was a nonresident for part or all of the taxable year, the resident spouse shall be allowed the full credit.

(B) If both spouses were nonresidents for part of the taxable year, the credit shall be divided equally between them subject to the

proration provided in subdivision (d) of this section.

(b) In the case of a husband and wife, if each spouse maintained a separate place of residence and resided in this state during the entire taxable year, each spouse will be allowed the full credit provided in subdivision (a).

(c) For purposes of this section, a "qualified renter" means an individual who on March 1 of the taxable year—

(1) Was a resident of this state, as defined in Section 17014, and

(2) On such date rented and occupied premises in this state which

constitute his principal place of residence

The term "qualified renter" does not include an individual who on March 1 of the taxable year rented and occupied premises which were exempt from property taxes, except that an individual, otherwise qualified, shall be deemed a qualified renter if he is required to pay property taxes on his possessory interest in a residence that is otherwise tax exempt during the taxable year.

The term "qualified renter" does not include an individual whose principal place of residence is with any other person who claimed

such individual as a dependent for income tax purposes.

The term "qualified renter" does not include an individual who has been granted or whose spouse has been granted the homeowners property tax exemption during the taxable year. This paragraph shall not apply in the case of an individual whose spouse has been granted the homeowners' property tax exemption if each spouse maintained a separate residence for the entire taxable year.

The term "qualified renter" does not include an individual or the spouse of an individual who, for the entire taxable year, received public assistance grants which took into account housing or shelter needs. If such grants were received for a part of the taxable year, the credit provided by this section shall be claimed at the rate of one-twelfth for each full month such grants were not received during the income year.

(d) Any individual who is a nonresident for any portion of the taxable year shall claim the credits set forth in subdivision (a) at the rate of one-twelfth of such credits for each full month such individual

resided within this state during the taxable year.

(e) Every person claiming the credit provided in this section shall, as part of such claim, and under penalty of perjury, furnish such information as the Franchise Tax Board prescribes on a form supplied by such board.

(f) The credit provided in this section shall be claimed on returns in such form as the Franchise Tax Board may from time to time prescribe, and shall be filed with the Franchise Tax Board on the date

prescribed by Section 18432.

- (g) For the purposes of this section, the term "premises" means a house or a dwelling unit used to provide living accommodations in a building or structure and the land incidental thereto, but does not include land only, except in the case where the dwelling unit is a mobilehome.
- (h) In the case of qualified renters whose credits provided in this section exceed their tax liability computed under this part, minus all other credits provided for in this part except the credits provided in Section 18551.1 and Section 17061, the qualified renter shall be allowed a credit to the extent of his tax liability plus a refund in excess of that amount up to a combined credit and refund equal to the credit otherwise provided in this section."

#### PRAYER

Upon invitation of Speaker pro Tempore Knox, the following prayer was offered by Archbishop Vatche Hovsepian, Primate, Armenian Church of North America Western Diocese

Mr Speaker and Members of the Assembly

For four evenings of last week, people throughout the United States watched the film "Holocaust" on TV During that nine hours of viewing, we all became witnesses to the senseless cruelty and butchery to which the Jewish people were subjected during the dark

days of World War II.

We watched, we listened, and it is no exaggeration to say, that in some degree, we all felt the tragedy that the Jewish people were experiencing at first hand. The true story of that horrible Holocaust of the Jewish people was told—and told well

Yet, we as Armenians, also have our story It is a story filled with loss, suffering, exhile, persecution, and the First Genocide of the Twentieth Century

Some 63 years ago today, on April 24, 1915, the Turkish Government began a dramatic extermination of the three million Armenians. They were able to massacre two million of our people, amongst them thousands of clergymen, writers, educators and scholars, who were systematically murdered, and the survivers were scattered or deported to the four corners of the world

Sixty-three years have gone by since the first Genocide, and yet,

nothing has been changed in Turkey today.

They have killed the Greeks, they have killed and deported the Jews, and they tried to annihilate the Armenian people Today, we are a pathetic minority in Turkey, yet our simple human rights as human beings are denied. Our people are being discriminated, our churches are left in ruins, because we are not permitted to repair or restore them.

As a servant of God, I have conducted services everywhere in the world, including the most atheistic countries, however, I am not

allowed to conduct services in Turkey

A few years ago in Turkey, His Eminence Archbishop Yakopos, Primate of the Greek Diocese of North and South America, was about to start the Celebration of Divine Liturgy, when Turkish policemen abruptly stopped him and ordered him to leave the country immediately.

Irrespective of who the victim is, it is totally incomprehensible that a thinking and reasoning man, created in the image of God, could be so passionately savage, so cruel, that he would be so inhuman against

his fellow man

Still some of our people had the good fortune to be led to this glorious and free United States of America Here, we began to rebuild our lives, our homes, our churches, our schools. And this, with God's Grace, and the freedom of this new land, was successful.

However, we have not yet been able to tell our story as the Jewish story has been told Both Jews and Armenians have been subjected to systematic Genocide Both had to painfully watch their lives, their homes, their families, their churches, and their schools be destroyed. Both had to endure the painful silence of the rest of the world which in spite of the horrors, remains untold

The Jewish story has been told yet, when we Armenians try to make our movies, the Turkish Government brings pressure to bear on the United States, the United States State Department in its terms brings pressure to bear on the film makers and producers, and the

film is never made

When we try to hold our exhibitions, the long hand of the Turkish Government reaches even into the halls of learning, as at the University of California at Berkeley, and exhibitions are withdrawn Still, we wait, we work, and we pray, to be able to tell our

story as it should be told, as truth and justice demands. We want the world to know about *our* Holocaust

It has been reported that when Hitler was questioned about world reaction to his extermination to the Jewish people, he replied very cynically, "Who now remembers the Armenian Genocide?"

One cannot help but wonder if the Jewish Hell in the 1940's could have been avoided if the world had demanded justice for the Armenians in 1915

With these feelings and hopes, we now pray

In Your Mercy O Lord, Remember and grant rest and illumination to the souls of our Martyrs of 1915 who died at the hands of the Turks. Likewise, we beseech You, O Lord, have mercy and compassion, and grant rest to all those in all times, in all places, who have suffered and died at the ruthless hands of consciousless and Godless aggression O Lord, let us the creation of Your hand, no longer hate, but grant us the wisdom that we may heed Your command that we love one-another, even as You have loved us O Lord, teach us all, that it is only as we live according to Your love for us and our love for each other, that suffering and injustice will pass from this world. Give us, O Lord, the grace and the wisdom to see this truth, and the strength of soul to carry it into practice in all our daily thoughts, words, and actions

O Provident and ever-compassionate Father of all, bless the President, the leaders, the lawmakers of our country, and, particularly, the members of this Chamber, upon whose judgement and decision is committed the destiny and happiness of us all We ask that You lead, guide, and direct their most important tasks to the end, where justice may always be established and the freedom which You have given us, is safeguarded

We humbly beseech You, O Lord, hear and grant our supplication now and forever AMEN
