I, GEORGE DEUKMEJIAN, Governor of the State of California, by virtue of the power and authority vested in me by Section 3(b) of Article IV of the Constitution of the State of California, do hereby convene the Legislature of the State of California, to meet in extraordinary session at Sacramento, California, on the 8th day of September, 1986, at 5:00 p.m. of said day for the following purpose and to legislate upon the following subject:

To consider and act upon legislation relative to prisons.
