# LAWS PASSED AT THE EXTRA SESSION.

## CHAPTER LXXVIII.

*An Act making appropriations to pay the expenses of the extra session of the Legislature, and other matters incidental thereto, of the State of California, during the thirty-second fiscal year.*

[Approved April 20th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The following sums of money are hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the expenses of the extra session of the Legislature, and other matters incidental thereto, to wit: Appropriation.

For the per diem and mileage of Assemblymen, twenty-one thousand dollars.

For pay of officers and Clerks of Assembly, three thousand five hundred dollars.

For contingent expenses of the Assembly, six thousand dollars.

For the per diem and mileage of the Lieutenant-Governor and Senators, ten thousand dollars.

For pay of officers and Clerks of the Senate, two thousand two hundred dollars.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXIX.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The sum of eight hundred dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for salary of the Deputy Supreme Court Reporter for the thirty-second fiscal year. Appropriation.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXX.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of five hundred and seventy-five dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for salaries of the Deputy Clerks of Supreme Court for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXXI.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of five hundred and ninety-seven dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for State portion of the salaries of Superior Judges for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXXII.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of seven thousand dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for the transportation of insane persons to the asylums for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

CHAPTER LXXXIII.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The sum of five thousand dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for the transportation of prisoners to State Prisons for the thirty-second fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

CHAPTER LXXXIV.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The sum of one thousand dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for the official advertising for the thirty-second fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

CHAPTER LXXXV.

*An Act making an appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The sum of eight thousand seven hundred and seventy-nine dollars is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for repairs to State Capitol building and furniture, and purchase of carpets, for the thirty-second fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXXVI.

*An Act making an appropriation to pay a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of twelve thousand dollars is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for purchase of stationery, fuel, lights, etc., for the Legislature and State officers, for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXXVII.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of three hundred and sixty dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for the postage and expressage in office of Superintendent of Public Instruction, for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

## CHAPTER LXXXVIII.

*An Act making appropriation for a deficiency in the appropriations for the thirty-second fiscal year.*

[Approved April 25th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of five thousand dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for support of State Printing Office for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

CHAPTER XC.

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The sum of eighty-eight dollars and eighty cents is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for pay of messenger for delivering election returns, under section thirteen hundred and ten, Political Code, for the thirty-second fiscal year.

SEC. 2. This Act shall take effect immediately.

CHAPTER XCI.

SECTION 1. The sum of four hundred dollars is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for salary of bookkeeper in the office of the Secretary of State for the thirty-second fiscal year.

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of three hundred dollars is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay a deficiency in the appropriation for the payment of rewards offered by the Governor, for the thirty-first fiscal year.

SEC. 2. This Act shall take effect immediately.



CHAPTER XCV.

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

The sum of three thousand and thirty-three dollars and fourteen cents is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for stationery, fuel, lights, etc., for the Legislature and State officers, for the thirty-first fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

CHAPTER XCVI.

*An Act making an appropriation to pay a deficiency in the appropriations for the thirty-first fiscal year.*

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The sum of three hundred and eighteen dollars and thirty-eight cents is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for repairs to State Capitol building and furniture, for the thirty-first fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

CHAPTER XCVII.

The sum of twenty-two dollars and forty cents is hereby appropriated out of any money in the State treasury not otherwise appropriated, to pay the deficiency in the appropriation for postage and contingent expenses of the Clerk of the Supreme Court, for the thirty-first fiscal year. <sup>Appropriation.</sup>

SEC. 2. This Act shall take effect immediately.

## CHAPTER XCVIII.

*An Act making an appropriation to pay a deficiency in the appropriations for the thirty-first fiscal year.*

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The sum of two hundred and sixty-one dollars and six cents is hereby appropriated out of any money in the General Fund of the State treasury not otherwise appropriated, to pay the deficiency in the salary of Register of Land Office, for the thirty-first fiscal year.

*An Act making appropriations for the support of the government of the State of California, for the thirty-third and thirty-fourth fiscal years.*

[Approved May 12th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. The following sums of money are hereby appropriated out of any money in the State treasury not otherwise appropriated, for the objects hereinafter expressed, and for the support of the government of the State of California, for the thirty-third and thirty-fourth fiscal years:

For the per diem and mileage of the Lieutenant-Governor and Senators, twenty-one thousand dollars. Senate and

For the per diem and mileage of Assemblymen, forty-one thousand five hundred dollars.

For pay of officers and Clerks of Senate, six thousand dollars.

For pay of officers and Clerks of Assembly, six thousand five hundred dollars.

For contingent expenses of the Senate, eight thousand five hundred dollars.

For contingent expenses of the Assembly, twelve thousand dollars.

For salary of Governor, twelve thousand dollars. Governor.

For salary of Governor's Private Secretary, six thousand dollars.

For salary of Executive Secretary, four thousand dollars.

For pay of Porter in Treasurer's office, six hundred dollars.

For postage and expressage and contingent expenses in Treasurer's office, three hundred dollars.

Attorney-General.

For salary of Attorney-General, six thousand dollars.

For salary of Deputy Attorney-General, four thousand eight hundred dollars.

For pay of Porter in Attorney-General's office, three hundred dollars.

For postage and expressage and contingent expenses in Attorney-General's office, two hundred dollars.

For traveling expenses of the Attorney-General, one thousand dollars.

For costs and expenses of suits, where the State is a party in interest, six thousand dollars.

Surveyor-General.

For salary of Surveyor-General, six thousand dollars.

For payment of armory rents, and other expenses of National Guard, one hundred and thirty-five thousand dollars. National Guard.

For salaries of Justices of the Supreme Court, eighty-four thousand dollars. Supreme Court.

For salary of Supreme Court Reporter, five thousand dollars.

For salary of Deputy Reporter of Decisions of Supreme Court, four thousand eight hundred dollars.

For salary of Clerk of Supreme Court, seven thousand five hundred dollars.

For salaries of Deputy Clerks of Supreme Court, eighteen thousand dollars.

For pay of Porter of Clerk of Supreme Court, six hundred dollars.

For pay of Phonographic Reporter of Supreme Court, six thousand dollars.

For salary of Secretaries to Justices of Supreme Court, six thousand four hundred dollars.

For salary of Bailiffs and Porter to Supreme Court, four thousand eight hundred dollars.

For postage and contingent expenses of Supreme Court, six hundred dollars.

For expenses of Supreme Court under section forty-seven of the Code of Civil Procedure, thirty thousand dollars.

- Yosemite Valley.** For salary of Guardian of Yosemite Valley, three thousand dollars.  
For traveling expenses of Board of Commissioners of Yosemite Valley, two thousand dollars.
- Water.** For water to be used in State Capitol building, twelve hundred dollars.
- Ventilation Capitol.** For the improvement of the ventilation of the State Capitol building, to be expended under the direction of the Board of State Capitol Commissioners, one thousand dollars.
- State Agricultural Society.** For aid of State Agricultural Society, fifteen thousand dollars.
- District Societies.** For aid of District Agricultural Society No. 1, four thousand dollars.  
For aid of District Agricultural Society No. 2, three thousand dollars.  
For aid of District Agricultural Society No. 3, three thousand dollars.  
For aid of District Agricultural Society No. 4, three thousand dollars.  
For aid of District Agricultural Society No. 5, twenty-four hundred dollars.  
For aid of District Agricultural Society No. 6, twenty-four hundred dollars.  
For aid of District Agricultural Society No. 7, twenty-four hundred dollars.  
For aid of District Agricultural Society No. 8, twenty-four hundred dollars.  
For aid of District Agricultural Society No. 9, sixteen hundred dollars.  
For aid of District Agricultural Society No. 10, sixteen hundred dollars.  
For aid of District Agricultural Society No. 11, sixteen hundred dollars.
- State burial grounds.** For care of the State burial grounds, and repair of monument erected by the State to the memory of ex-Governor John Bigler, five hundred dollars.
- State Normal School, San José.** For furnishing State Normal School at San José, ten thousand dollars, for the thirty-third fiscal year.
- University.** For furnishing Bacon Art and Library Building at State University, ten thousand dollars.  
For the Mechanical and Mining Art College, to continue the operations of and to advance the instruction in said college at the State University, eight thousand dollars.  
For continuing the special investigations and operations of the Agricultural Department of the State University, ten thousand dollars.



For the furnishing Branch State Normal School at Los Angeles, two thousand five hundred dollars.

For support of Branch State Normal School at Los Angeles, for the thirty-fourth fiscal year, seven thousand five hundred dollars.

SEC. 2. The sums that are herein appropriated for contingent expenses of the Senate and Assembly shall be disbursed under the direction of the bodies to which they respectively belong, and shall not be subject to any of the provisions of section six hundred and seventy-two of the Political Code. No moneys appropriated for the support of the institutions of the State shall be used for permanent improvements, but shall be used solely for the payment of salaries and traveling expenses of the Commissioners or Directors having charge of the same, when such salaries or expenses are allowed by law; the salaries of employes; the purchase of materials and supplies for the use of the said institutions, and for such incidental and current expenses as may be necessarily incurred for the proper management and support of said institutions.

Appropriations, how used.

SEC. 3. The various State officers, and the officers of all institutions under the control of the State, except the Governor, to whom and for which appropriations other than salaries are made under the provisions of this Act, shall, with their biennial report, submit a detailed statement, under oath, of the manner in which all appropriations for their respective departments and institutions have been expended; and the State Board of Examiners are hereby expressly prohibited from allowing any demands payable out of such appropriations until the same are presented in itemized form, stating specifically the service rendered, by whom performed, time employed, distance traveled, and necessary expense thereof; if for article purchased, the name of each article, together with the price paid for each, and of whom purchased, with the date of purchase; *provided*, that no officer shall use or appropriate any money for any purpose whatsoever, appropriated by this Act, unless authorized thereto by law.

Officers to submit statement.

SEC. 4. Not more than one half of the respective appropriations made under this Act shall be expended during the thirty-third fiscal year, unless the same has been expressly authorized as hereinbefore provided.

I approve of this Assembly Bill, No. 8, entitled "An Act making appropriations for the support of the government of the State of California for the thirty-third and thirty-fourth fiscal years," with the exception of the following item of appropriation, to which I object, to wit: "For the purchase of lime, cement, and other articles necessary for the construction of a wall about the State Prison at Folsom, ten thousand dollars."

## CHAPTER CII.

*An Act making appropriations to pay the expenses of the extra session of the Legislature, and other matters incidental thereto, of the State of California, during the thirty-second fiscal year.*

*The People of the State of California, represented in Senate and Assembly, do enact as follows:*

Appropriation.

SECTION 1. The following sums of money are hereby appropriated out of any money in the General Fund not otherwise appropriated, to pay the expenses of the extra session of the Legislature, and other matters incidental thereto, to wit:

For the per diem of Assemblymen, ten thousand dollars.

For pay of officers and clerks of Assembly, one thousand seven hundred and fifty dollars.

For contingent expenses of the Assembly, three thousand dollars.

For the per diem of the Lieutenant-Governor and Senators, five thousand dollars.

For pay of officers and clerks of Senate, one thousand one hundred dollars.

For contingent expenses of the Senate, two thousand dollars.

*Provided*, that so much of the several sums herein specified as shall not have been expended at the close of the session shall be returned to the General Fund.

SEC. 2. This Act shall take effect immediately.

This bill having been returned by the Governor with his objections thereto, and, after reconsideration, having passed both houses of the Legislature by two thirds of all members elected required by the Constitution, it has become a law this eleventh day of May, A. D. 1881.

CHAPTER CIII.

*An Act to amend Section 3713 of the Political Code, and to provide for the levy of the tax for State purposes for the thirty-third and thirty-fourth fiscal years.*

[Approved May 12th, 1881.]

*The People of the State of California, represented in Senate and Assembly, do enact as follows :*

SECTION 1. Section three thousand seven hundred and thirteen of the Political Code is hereby amended to read as follows:

**3713.** The State Board of Equalization must, for State purposes, for the thirty-third and thirty-fourth fiscal years, fix such an ad valorem rate of taxation upon each one hundred dollars in value of taxable property of this State, as, after allowing twelve per cent. for delinquencies in and costs of collection of taxes, as provided in section three thousand six hundred and ninety-six of this Code, will raise for the thirty-third fiscal year : Rate of taxation.

*First*—For the General Fund, two million one hundred and ninety thousand and eighty-four dollars.

*Second*—For the School Fund, one million three hundred thousand dollars.

*Third*—For the Interest and Sinking Fund, three hundred and fifteen thousand dollars.

And for the thirty-fourth fiscal year:

*First*—For the General Fund, one million four hundred and eighty-eight thousand seven hundred and thirty-five dollars.

*Second*—For the School Fund, one million three hundred thousand dollars.

*Third*—For the Interest and Sinking Fund, three hundred and ninety-eight thousand dollars.

SEC. 2. This Act shall take effect immediately.

# RESOLUTIONS PASSED AT EXTRA SESSION.

## CHAPTER XXIII.

*Assembly Concurrent Resolution No. 5, relative to instructing our Senators in Congress to use all honorable means to secure the speedy ratification of the treaty made and entered into between the Emperor of China and the Commissioners of the United States.*

[Adopted May 5th, 1881.]

WHEREAS, A treaty was made and entered into between the Emperor of China and Commissioners appointed by the Government of the United States of North America, which treaty was signed at the City of Pekin on the seventeenth day of November, eighteen hundred and eighty; and whereas, by the stipulations of said treaty the said treaty is required to be confirmed, ratified, and exchanged at the City of Pekin on or before the seventeenth day of November, A. D. eighteen hundred and eighty-one, by their respective governments, and in default thereof, the said treaty will become null and void; and whereas, in the opinion of this Legislature, it is of the highest importance to the future growth, and welfare, and happiness of the people of the State of California and the Pacific Coast that the said treaty should be confirmed, ratified, and exchanged at the City of Pekin on or before the seventeenth day of November, A. D. eighteen hundred and eighty-one; therefore, be it

*Resolved by the Assembly, the Senate concurring,* That our Senators in Congress representing the State of California, be instructed to use all honorable means to have the provisions of said treaty acted upon by the Senate of the United States in time to have said treaty ratified, confirmed, and exchanged in accordance with provisions of said treaty at the City of Pekin, on or before the seventeenth day of November, A. D. eighteen hundred and eighty-one.

*Be it further resolved,* That the Governor of this State be and is hereby requested to transmit a true copy of the above preamble and resolutions, and forward the same to our respective Senators in Congress from the State of California.

## CHAPTER XXIV.

*Assembly Concurrent Resolution No. 7, relative to adjournment sine die of the Legislature of the State of California.*

[Adopted May 12th, 1881.]
