### Digest

The Summary Digest consists of a short summary of each law enacted, and each concurrent or joint resolution adopted at the 1967 Second Extraordinary Session of the Legislature. Each digest is the Legislative Counsel's digest which appeared on the face of the legislative measure when placed on final passage by both houses.

### Cross-Reference Tables

The text of the summary is arranged numerically by chapters. A cross-reference table is included which designates chapter number of each legislative measure enacted by bill number or resolution number.

### Index

A subject matter index to all measures including resolutions is included.

This edition of the Summary Digest includes a table of sections affected by laws enacted. ## NOTES ON EFFECTIVE DATES

The 1967 Second Extraordinary Session convened on November 6, 1967, and adjourned sine die December 8, 1967. Statutes, other than those taking immediate effect, take effect on March 8, 1968. Digests note statutes taking effect by "*In effect immediately.*"

The effective date of a joint or concurrent resolution is the date it is filed with the Secretary of State.

## BILL CHAPTERS

Ch. 1 (SB 3) WHETMORE Adds Sec. 155.10, R & T.C., re disaster area tax relief.

Authorizes board of supervisors of any county to provide for the reassessment of property damaged or destroyed between October 8, 1967, and November 6, 1967, by a major fire in an area subsequently proclaimed by the Governor to be in a state of disaster, if the damage to the property is in excess of \$1,000. Specifies that  $\frac{1}{3}$  of the property tax shall be computed on the property's value as originally assessed and  $\frac{2}{3}$  on the value of the property as reassessed after the major fire.

*In effect immediately.*

Ch. 2 (AB 9) FENTON Repeals, adds Ch. 1 (commencing with Sec. 30000), Div. 16, Elec.C., re reapportionment of congressional districts.

Reapportions congressional districts.

Ch. 3 (SB 6) DEUKMEJIAN Amends Sec. 18242, R. & T.C., re personal income tax: averaging.

Provides with respect to computation of base period income for purposes of personal income tax averaging that for taxable year beginning prior to January 1, 1967, such income shall be increased by the amount of the deductions for personal exemption claimed for such year.

*In effect immediately.*

Ch. 4 (SB 7) BURGNER Amends Secs. 14115 and 14616, W & I.C., re California Medical Assistance Program.

Provides that bills for service under Medi-Cal program shall be submitted two, rather than six, months after the month in which the service is rendered; but provides that the administrator may, where he finds that delay in the submission of bills was caused by circumstances beyond the control of the provider of such services, extend this period for a period not to exceed one year.

*To become operative on July 1, 1968.*

## RESOLUTION CHAPTERS

Res. Ch. 1 (SCR 1) COLLIER Parking of vehicles.

Requests California Highway Patrol and all city and county law enforcement agencies to delay the enforcement of Section 22518 of the Vehicle Code for a period of 120 days from its effective date of November 8, 1967, due to the public inconvenience and unintended hardship that such legislation would create in restricting nighttime parking of trailer coaches, housecars, or vehicles equipped with a camper upon any highway.

Res. Ch. 2 (SCR 3) BURGNER Retarded Children's Week.

Requests Governor to proclaim period from November 12 to November 23, 1967, as Retarded Children's Week.

Res. Ch. 3 (SCR 4) SCHRADE California Citizenship Day.

Request Governor to proclaim November 13, 1967, as California Citizenship Day.

Res. Ch. 4 (ACR 4) ELLIOTT Legionarios del Trabajo in America.

Commends Legionarios del Trabajo in America on occasion of its second triennial convention in Sacramento.

Res. Ch. 5 (ACR 5) HAYES Motor vehicle pollution control.

Directs State Air Resources Board to apply emission standards to each and every new gasoline-powered, reciprocating-engine passenger vehicle sold in this state.

Res. Ch. 6 (ACR 7) WILSON State-supported bands.

States there was no legislative intent to have Section 6650 of the Government Code apply to performances by a publicly supported school band or orchestra taking place outside the State of California.

Res. Ch. 7 (AJR 1) SCHABARUM Air pollution: motor vehicles.

Commends the Congress of the United States for not precluding California from adopting stricter standards for the control of emissions of air pollutants from motor



vehicles, as the problem is a matter of state concern which can be effectively dealt with only on a local basis as the need arises and particularly commends the concerted action of the California Congressional Delegation and other state and local government officials in securing the deletion of a proposed amendment to the Federal Air Quality Act which would have eliminated the right of this state to establish and enforce new motor vehicle smog control standards.

Res. Ch. 8 (SJR 1) SCHRADER California's bicentennial.

Petitions the Postmaster General of the United States to have issued in 1969 a commemorative stamp in honor of California's bicentennial and of Governor Gaspar de Portolá and Fray Junípero Serra.

Res. Ch. 9 (ACR 6) MACDONALD Notaries public.

Clarifies legislative intent as to meaning of Section 8201 of the Government Code, as amended by Section 2 of Chapter 1139 of the Statutes of 1967, relating to notaries public.

Res. Ch. 10 (AJR 2) Z'BERG Charles M. Weber Foundation.

Memorializes President and Congress to take steps necessary to ensure that application of Captain Charles M. Weber Memorial Foundation to Department of Interior for a grant of funds for water resources research be acted upon favorably.

Res. Ch. 11 (ACR 9) STULL Motor vehicle windows.

Requests California Highway Patrol and all county and city law enforcement agencies to delay the enforcement of Section 26708 of the Vehicle Code for a period of 120 days from its effective date of November 8, 1967, insofar as such section may prohibit the operation of any motor vehicle which has tinting material placed upon the rear window or rear windows thereof in any case where such motor vehicle is equipped with outside mirrors on both the left- and right-hand sides of the vehicle so located as to reflect to the driver a view of the highway through each mirror for a distance of at least 200 feet to the rear of such vehicle.

Res. Ch. 12 (ACR 16) RUSSELL Pearl Harbor Remembrance Day.

Requests the Governor to proclaim December 7, 1967, as Pearl Harbor Remembrance Day.

Res. Ch. 13 (SCR 2) SCHMITZ Veterans Memorial Highway.

Designates State Highway Route 73 the Veterans Memorial Highway.

Res. Ch. 14 (AJR 5) MURPHY California Migrant Master Plan.

Requests Director of the United States Office of Economic Opportunity to expand housing and related programs for migratory workers under the California Migrant Master Plan.

Res. Ch. 15 (ACR 11) VENEMAN Financing of the Medi-Cal program.

Declares moratorium on legislative or administrative action regarding the financing of Medi-Cal until special joint legislative committee created by this resolution renders its report on that subject to the Legislature, not later than February 29, 1968.

Allocates \$50,000 for committee expenses.

Res. Ch. 16 (ACR 15) CROWN Crippled Children Services Program.

Requests Governor, Administrator of the Health and Welfare Agency, and Director of Public Health to rescind Crippled Children Services Bulletin 67-4.

Encourages Director of Finance to authorize county expenditure upon Crippled Children Services Program of state's share of money received as reimbursement.

Res. Ch. 17 (ACR 17) UNRUH Adjournment of special session.

Provides Second Extraordinary Session of 1967 Legislature will adjourn sine die at 12 noon on December 8, 1967.

Res. Ch. 18 (AJR 6) KETCHUM Aviation.

Memorializes Federal Aviation Agency not to amend or discontinue the Special Visual Flight Rules weather minimums.
