**INTRODUCTION AND FIRST READING OF

ASSEMBLY BILL NO. 5—Floyd. An act to amend Section 16419 of the Government Code, and to amend Section 7102 of, and to add Sections 6051.6, 6201.6, and 6376.3 to, the Revenue and Taxation Code, relating to disaster relief, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.
