The following bills were introduced and read the first time: **ASSEMBLY BILL NO. 7—Oller and Brown.** An act relating to tourism, and making an appropriation therefor.

ASSEMBLY BILL NO. 8—Martinez. An act to add Article 6 (commencing with Section 8693) to Chapter 7.5 of Division 1 of Title 2 of the Government Code, and to amend Sections 7071, 7072, 7073, 7101, and 19601 of, to add Section 7076 to, and to add Chapter 9.1 (commencing with Section 19730) to Part 10.2 of Division 2 of, the Revenue and Taxation Code, relating to disaster relief, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 9—Martinez. An act to add Chapter 12.49 (commencing with Section 8879.30) to Division 1 of Title 2 of the Government Code, relating to financing a transportation infrastructure program by providing the funds necessary therefor through the issuance and sale of bonds of the State of California and by providing for the handling and disposition of those funds, and declaring the urgency thereof, to take effect immediately.
