#### Reply by Speaker pro Tempore Kuehl

The Speaker pro Tempore replied in the negative.

#### **Point of Order**

Assembly Member Villaraigosa arose to the following point of order:

The motion to adjourn is not debatable, and Assembly Member Pringle is debating the motion to adjourn.

# **Ruling by Speaker pro Tempore Kuehl**

The Speaker pro Tempore ruled the point of order well-taken that the motion to adjourn is not debatable, but stated that Assembly Member Pringle had arisen to a parliamentary inquiry.

Assembly Member Oller arose to speak on the condition of the file.

# **Parliamentary Inquiry**

Assembly Member McClintock arose to the following parliamentary inquiry:

What is the maximum period of time that the Extraordinary Session may be in recess before it must be reconvened under the Constitution, or dissolved?

# Reply by Speaker pro Tempore Kuehl

The Speaker pro Tempore replied that pursuant to the Constitution the Assembly may not recess the Extraordinary Session for more than 10 days, without consent of the other House.

#### Motion to Adjourn Until June 23, 1997

Assembly Member McClintock moved that the Assembly adjourn the First Extraordinary Session until Monday, June 23, 1997.

#### **Motion Ruled Out of Order**

Speaker pro Tempore Kuehl ruled that although the motion by Assembly Member McClintock is in order under Mason's, under the Assembly Rules which take precedence, the motion to adjourn takes precedence over a motion to adjourn to a certain time.

## **Parliamentary Inquiry**

Assembly Member McClintock arose to the following parliamentary inquiry:

When will the House reconvene the First Extraordinary Session, and will the membership be advised?

# Reply by Speaker pro Tempore Kuehl

The Speaker pro Tempore replied that the First Extraordinary Session would reconvene within the next 10 days pursuant to the Constitution, and that the request would be made of the Speaker that the membership be advised.

#### Motion to Reconsider Assembly Bill No. 6 on Next Legislative Day

Assembly Member Bordonaro moved to reconsider on the next legislative day the vote whereby Assembly Bill No. 6 was this day passed.

#### **Motion Ruled Out of Order**

Speaker pro Tempore Kuehl ruled the Bordonaro motion to reconsider out of order pursuant to Assembly Rule 100, as the motion to adjourn takes precedence.
